2015 SCHOLARSHIP

The Champaign County Farm Bureau is offering an \$800 scholarship award to Champaign County Farm Bureau members' children, who are majoring in Agriculture. The scholarship is for the purpose of continuing higher education at a two or four year college or university.

QUALIFICATIONS – Applications will be accepted from students meeting the following qualifications:

1. Must be a high school senior or graduate of a Champaign County high school.
2. Must be enrolled as a full-time student in a four year college or university agricultural program, or in a two year college agricultural program for Fall Quarter/Semester of 2015.
3. Parents must be a Champaign County Farm Bureau member prior to applying.
4. Applicant may not have been a previous winner of this scholarship.

CONDITIONS OF THE SCHOLARSHIP – The award will be used towards the student's tuition and fees and will be processed through the scholarship office of the chosen school.

SELECTION – Selection of the final applicants will be made by the Champaign County Farm Bureau Board of Trustees.
