Hamilton County Farm Bureau Scholarship Rules & Eligibility

- You must be a FFA member in Hamilton County
- You must have or will have obtained the ranking of High School Senior or College Freshman status at the time the scholarship is awarded.
- Application must be returned to the Hamilton County Farm Bureau office no later than April 1 of this year the Scholarship is to be awarded.
- Scholarship will be awarded to the recipient upon the receipt of a grade card/paid receipt from a college or trade school of applicant's choice.
- This scholarship will be awarded to an individual only once, however an individual can apply both years of eligibility.
- There will be only one scholarship awarded each year to a qualified applicant.
- Applicants may be subject to an interview.
