

**Logan County Impact Fund Raffle**  
**OFFICIAL RAFFLE RULES**

By participating, you agree that:

1. All net proceeds of this raffle will benefit the Logan County Impact Fund of the Ohio Farm Bureau Foundation (OFB Foundation), an Ohio non-profit corporation, recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue Code.
2. A maximum of 250 raffle tickets will be sold at \$100 each. Each ticket will be entered separately in the drawing. Each ticket has a separate and equal chance of winning as prizes are being drawn. The chance of winning is one divided by the number of tickets sold (maximum 1/250). There is no limit to the number of raffle tickets a participant may purchase.
3. If all 250 tickets are sold, there will be one grand prize of \$5,000, one 1st runner-up prize of \$2,000, one 2nd runner-up prize of \$1,000, and ten auxiliary prizes ranging from \$50 each. There will also be a "losers prize" of \$500. All tickets not selected for the grand prize, a runner-up prize, or an auxiliary prize will be eligible for the loser's prize drawing.
4. If fewer than 250 tickets are sold, the total of all prizes awarded will be 30% of the total tickets sold, with each prize reduced proportionally so the sum of all prizes awarded equals 30% of all tickets sold.
5. The raffle will be conducted as a reverse raffle, meaning that the last ticket drawn will win the grand prize. The schedule of when other prizes will be drawn will be announced on the date of the raffle before the drawing begins and will depend upon the number of tickets sold. One ticket will be held back and auctioned off when there are only four tickets remaining in the drawing for the grand prize, and that auctioned ticket will be added to the drawing with the other four.
6. There will be a 2<sup>nd</sup> chance board. The number of spots on the board will match the number of tickets sold in the reverse raffle (maximum 250). Any person may purchase one or more numbers on the 2<sup>nd</sup> chance board for \$10 per number. Each number may only be purchased once and every number need not be purchased. When the winning ticket for the reverse raffle grand prize is drawn, the holder of the corresponding number on the insurance board (if that spot is held) will win 50% of the 2<sup>nd</sup> chance board pot.
7. All drawings will be held at the Winner Harvest Barn in DeGraff, Ohio, on April 6, 2024. Winners need not be present to win. If not present, the winner will be notified by telephone or mail.
8. Participants must be at least 18 years old and residents of the state of Ohio on the date of the drawing. Prize winners must produce photo identification including proof of Ohio residency and age when claiming their prizes. Winners have 30 days from the date of the raffle drawing to claim their prizes, or else they shall forfeit all rights and claims thereto.
9. Tickets may be purchased by credit card by calling the county office at 877-775-7642 or with this link <https://www.cognitofrms.com/FarmBureau8/LoganCountyAgImpactFundReverseRaffle>, or through the mail by check or through Logan County Farm Bureau members and authorized OFB Foundation employees by cash or check. Checks should be made payable to the Ohio Farm Bureau Foundation. Credit cards accepted are Visa, Mastercard, and Discover.
10. Due to postal regulations, raffle ticket stubs cannot be mailed. When an order is placed online or over the phone, an authorized representative from the OFB Foundation will complete the ticket by filling in the name, address and phone number provided and will ensure the raffle ticket is entered in the drawing. The ticket stub can then be picked up in person either before or at the drawing.
11. The cost of raffle tickets purchased is not tax deductible. Prizes may be taxable to the winner. Winners are solely responsible for all federal, state, and local taxes. Please consult your tax advisor.
12. Ticket sales to OFB Foundation employees, officers, board members, and their immediate families are prohibited. Immediate family includes spouse, children, and children's spouse.
13. Any person who engages in conduct designed to corrupt the outcome of a charitable gaming activity with the purpose to defraud, or knowing that he is facilitating a fraud, is subject to criminal prosecution under all applicable federal, state, and local laws.
14. The OFB Foundation reserves the right to cancel this raffle at any time, in which event its liability is limited to the refund of ticket prices to participants.
15. These official raffle rules may not be waived, modified, or supplemented except by the OFB Foundation.
