

### **James (Bill) Patterson, President (District 4)**

Bill Patterson of Chesterland was elected president of Ohio Farm Bureau Federation in April 2021. He joined the board as District 4 trustee in 2011 representing Farm Bureau members in Ashtabula, Geauga, Lake and Trumbull counties. Patterson farms with his family, raising apples, strawberries and peaches. They also have a farm market and a wholesale cider operation. Patterson received his bachelor's degree in agricultural economics from Ohio State University.



### **Cy Prettyman, First Vice President (District 7)**

Cy Prettyman of New Bloomington was elected first vice president of Ohio Farm Bureau Federation in April 2021. He has served as District 7 trustee for the Ohio Farm Bureau Federation since 2012, representing members from Crawford, Marion, Morrow and Richland counties. Prettyman farms with his family, raising corn, soybeans, and has a direct-to-consumer beef enterprise. In addition, he has an over 35-year agricultural career serving members in Ohio's cooperative system. He has a bachelor's degree in animal sciences from The Ohio State University and serves as a trustee on the Mid-Ohio Energy Cooperative. He also has served on the Ohio Livestock Care Standards Board since 2016 and has been active with local and state Pork Producers Councils and Ohio Cattlemen's Association.



### **Adele Flynn, Treasurer (District 3)**

Adele Flynn of Wellington was elected Treasurer in April 2024. She has served as District 3 trustee representing members from Cuyahoga, Erie, Huron and Lorain counties since September 2018. She and her husband, Eric, have three children and farm full time. They have a cow-calf operation, raising freezer beef, show calves and breeding stock. The Flyns also are partners of Gordon Farms, growing approximately 1,100 acres of cash grains. Adele is a 4-H advisor, serves on the board of directors for Centerra Co-op, the Ohio Soybean Council, and the World Initiative for Soy in Human Health and has served as delegate for the Council for Agricultural Research, Extension and Teaching for The Ohio State University.



### **Nate Andre, District 1**

Nate Andre of Wauseon was elected District 1 trustee in December 2025. He represents members from Defiance, Fulton, Henry, and Williams counties. Andre operates a composting, organic nutrient recovery operation and a Class II compost facility with the U.S. Environmental Protection Agency, in partnership with his brother, Paul. They also farm corn and soybeans in northwest Ohio. He earned a bachelor's degree in agricultural education and ag mechanization systems from The Ohio State University. He is a 30-year member of the Extension Professionals Organization and the Council for Agricultural Research, Extension, and Teaching. Andre started with the Ohio Farm Bureau in the 1970s.



### **Bill Myers, District 2**

Bill Myers of Oregon was elected District 2 trustee in December 2021. He represents the interests of Farm Bureau members from Lucas, Ottawa, Sandusky and Wood counties. Myers farms with his brother, Bob, and his son and daughter. The farm produces corn, soybeans, wheat and hay. Myers is a member of Lucas County Farm Bureau. He participated in AgriPOWER Class I. He is a member of the Lake Erie Waterkeeper Association and CedarCreek Church in Perrysburg.



### **Craig Pohlman, District 5**

Craig Pohlman of Venedocia was elected as District 5 trustee for the Ohio Farm Bureau Federation in December 2019. He represents Farm Bureau members in Allen, Paulding, Putnam and Van Wert counties. Pohlman and his wife, Sheila, have three children and raise corn, soybeans and grain sorghum. He is a Van Wert County Farm Bureau member and graduate of AgriPOWER Class IX. An Ohio State University graduate with a degree in agriculture economics, Pohlman is an independent seed salesman and is active with the Van Wert Soil and Water Conservation District.



**John Bolte, District 6**

John Bolte of Tiffin was elected to the board in December 2022. He represents the interests of members from Hancock, Hardin, Seneca and Wyandot counties.

Bolte and his wife, Sarah, operate Bolte Farms, a small grain farm and pumpkin operation, which also includes an 1860s bank barn, Arlington Acres Ohio, that is used as a wedding venue. He is a trader for Seneca Trading, LLC, is a graduate of Ohio Farm Bureau's AgriPOWER leadership development program and previously served as a co-chair on the Young Agricultural Professionals State Committee. He also is serving on the Ohio AgriBusiness Association's Membership Committee and Grain and Feed Task Force. He has a bachelor's degree in agricultural business and applied economics from Ohio State University.

**Matt Vodraska, District 8**

Matt Vodraska of Doylestown was elected District 8 trustee for the Ohio Farm Bureau Federation in December 2023. He represents members in Ashland, Medina, Summit and Wayne counties. Vodraska farms with his brother on a diversified specialty fruit operation where they produce estate wines and ciders on the family farm south of Wadsworth. He was named Ohio Farm Bureau's Outstanding Young Farmer in 2019 and was a member of the inaugural AgriPOWER class in 2009. He also has been active with the Ohio Grape Association, Midwest Apple Improvement Association and Ohio Produce Growers & Marketers Association.

**Danielle Burch, District 9**

Danielle Burch of Salem was elected District 9 trustee in May 2021 and represents members in Columbiana, Mahoning, Portage and Stark counties. Burch and her husband, Andrew, have three children and operate a 250-acre freezer beef and pork operation in Salem, where she is a member of the Winona Fire Department Auxiliary and Hanoverton Church of Christ. She is a member of Columbiana County Farm Bureau, and was a member of the OFBF Young Ag Professionals State Committee. She is a graduate of American Farm Bureau Federation's Women's Communications Boot Camp. Burch received her bachelor's degree in political science and history at the University of Mount Union in Alliance and master's degree in education at St. Joseph's University in Philadelphia.

**Matt Schmerge, District 10**

Matt Schmerge of Botkins was elected District 10 trustee in December 2025, representing members from Shelby, Auglaize, Mercer, and Logan counties. Schmerge farms 150 acres of grain with his family. He graduated with a bachelor's degree in agricultural economics from The Ohio State University and has been working in agriculture ever since. He currently works for Danone North America, working with dairy farms and regenerative agriculture. Schmerge is a member of the Shelby County Farm Bureau and has served on various committees.

**Katherine Harrison, District 11**

Katherine Harrison of Canal Winchester was elected District 11 trustee in 2011, representing members in Delaware, Franklin, Madison and Union counties. She is the owner of Harrison Farm, where she raises goats, sheep and chickens. Harrison Farm provides agritourism opportunities for visitors from the metropolitan area, offers educational internships for students, and is a farm incubator for young agriculturalists. Harrison is a graduate of AgriPOWER Class II and served as a McCloy Fellow in 2011. She holds a bachelor's degree in history and world religions from the University of Richmond.

**Paul Davidson, District 12**

Paul Davidson of Newark was elected District 12 trustee in December 2024, representing members in Coshocton, Holmes, Knox and Licking counties. Davidson is a member of Licking County Farm Bureau. He also previously served on the Ohio Farm Bureau board from 2011 to 2018. An Ohio State University graduate with a degree in agricultural economics and rural sociology, Davidson produces hay and is a project manager for a local excavating company. He is currently the president of the Utica FFA Alumni Association, a 4-H advisor, member of FFA Alumni and currently serves as a trustee on the Licking Land Trust.

**Todd Davis, District 13**

Todd Davis of Carrollton was elected District 13 trustee in December 2025, representing members from Carroll, Harrison, Jefferson, and Tuscarawas counties. Davis and his wife, Kim, operate a family-owned cow-calf operation in Carroll County. He recently retired as the director of Ohio FFA Camp Muskingum and previously served as an agricultural educator at Benjamin Logan High School and as the Ohio Farm Bureau organization director for Carroll, Harrison, Jefferson, and Tuscarawas counties. He has also served on the Carrollton Farmers Exchange Program Board and the Empower Youth Coalition for Carroll County. Davis is a graduate of The Ohio State University, where he earned a degree in agricultural education and agricultural economics.



**Matt Aultman, District 14**

Matt Aultman was elected District 14 trustee for the Ohio Farm Bureau Federation in December 2020 and represents the interests of Farm Bureau members in Champaign, Clark, Darke and Miami counties. He and his wife, Morgan, and their children raise row crops, hay, produce, mums, cut flowers, Nigerian Dwarf goats, chickens, and show rabbits. He is a feed nutritionist at Treaty Mills, LLC and also helps his grandfather and father with their daily farm operations. Aultman attended Edison State Community College to study business and machine engineering. He serves as a Darke County commissioner and sits on many boards, including the Coalition for a Healthy Darke County, Wayne HealthCare Foundation, Darke County Economic Development, Darke County Visitors Bureau and the American Red Cross.

**Michael Videkovich, District 15**

Michael Videkovich of Ashville was elected to the Ohio Farm Bureau board of trustees in 2013, representing members in Fairfield, Hocking, Pickaway and Ross counties. He and his wife, Kim, farm with her parents raising corn, soybeans, wheat, forage crops and beef cattle. He is a Pickaway County Farm Bureau member, a graduate of Farm Bureau's AgriPOWER leadership development program and is a member of American Farm Bureau's Grassroots Outreach Team. He is an Ohio State University graduate and previously served as an IT supervisor at the Ohio Police and Fire Pension Fund. He and his wife have three children.

**Vince Untied, District 16**

Vince Untied of Frazeysburg was elected District 16 trustee in December 2024 representing members in Guernsey, Morgan, Muskingum and Perry counties. Untied operates a cow/calf seedstock and show cattle operation and is currently the CAUV director for the CAUV & Agriculture Districts Program in Licking County. He is a graduate of West Virginia University, earning a degree in wildlife and fisheries management. He is a member of Muskingum County Farm Bureau. He is also a graduate of Ohio Farm Bureau's AgriPOWER leadership program, Class IX.

**Al Miller, District 17**

Al Miller of Marietta was elected District 17 trustee in 2008 and represents members in Belmont, Monroe, Noble and Washington counties. He and his wife, Jean, own a commercial cow-calf farm where they also produce hay. Miller is a township trustee, a delegate for United Producers, Inc. and he serves on the Washington County Planning Commission. He has been involved with county farmland preservation efforts.

**Lane Osswald, District 18**

Lane Osswald of Eldorado was elected District 18 trustee in 2011. He represents members from Butler, Hamilton, Montgomery and Preble counties. Osswald and his wife, Bambi, have four children and farm with his parents and two brothers, growing corn, soybeans, wheat, cover crops, vegetables and providing custom farming services. The Ohio State graduate owns and operates Growing Acres Farm and sells Stine seed. In addition, Osswald is a member of Ware's Chapel United Methodist Church and the Preble County Chamber of Commerce.

**Nicol Reiterman, District 19**

Nicol Reiterman of Washington Court House was elected to the board of trustees in December 2022. She represents the interests of Farm Bureau members from Clinton, Fayette, Greene and Warren counties. Reiterman and her husband, Mike, farm 1,300 acres of corn, soybeans, wheat, and malting barley. In addition, they own and operate Reiterman Seed Farms, and Nicol serves as co-manager of the family run feed store, Reiterman Feed and Supply. She is a Fayette County Farm Bureau member.

**Evan Davis, District 20**

Evan Davis of Leesburg was elected District 20 trustee in December 2025. He represents members from Adams, Brown, Clermont, and Highland counties. Davis co-runs Davis Ag with his father, where they operate a 2,200-acre grain farm and 60-head cow-calf operation. He earned a degree in agricultural and construction systems management from The Ohio State University and is a member of Highland County Farm Bureau.

**Greg Williams, District 21**

Greg Williams of Lucasville was elected District 21 trustee in December 2024, representing Farm Bureau members in Jackson-Vinton, Pike and Scioto counties. Williams feeds out bulls in partnership with a local dairy as he builds a direct-to-consumer market for high-quality beef. He is a member of the Scioto County Farm Bureau and also served on the Ohio Farm Bureau Young Agricultural Professionals State Committee. He is a graduate of Shawnee State University, receiving a degree in secondary education and is a school psychologist for South Central Ohio Educational Service Center.



**Gary Truance, District 22**

Gary Truance of Vinton was elected District 22 trustee in December 2024, representing Farm Bureau members in Athens-Meigs, Gallia and Lawrence counties. Truance and his family have a custom feedlot and feed cattle for themselves from a row crop operation of corn, soybeans and hay. He is a member Gallia County Farm Bureau and is a member of the Gallia County Soil & Water board.

**Hannah DiVencenzo, Northeast Regional Trustee**

Hannah DiVencenzo of Grafton was elected northeast regional trustee in December 2024, representing Farm Bureau members from 20 northeast Ohio counties. She is the owner of Healthy Harvest Organics, where she operates a small family farm focused on regenerative agriculture. Off the farm, she is a program developer at Lorain County Community College. She is a member of the Lorain County Farm Bureau and has served on the Ohio Farm Bureau Young Ag Professionals State Committee.

**Greg Wells, Southeast Regional Trustee**

Greg Wells of Chillicothe was elected to the Ohio Farm Bureau Federation board in December 2023. He represents Farm Bureau members in 24 southeastern Ohio counties. Wells works with his dad and brother to raise a registered Angus beef herd and they have a row crop operation. Wells is a member of the Ross County Farm Bureau and has been active with Ohio Farm Bureau advocacy efforts. With a professional engineer's license, Wells has focused on civil and conservation engineering work. He is a graduate of The Ohio State University's Department of Food, Agricultural and Biological Engineering.

**Rose Hartschuh, Northwest Regional Trustee**

Rose Hartschuh of Sycamore was elected northwest regional trustee in December 2018 and represents members from 24 counties. She and her husband, Greg, were the American Farm Bureau 2018 Excellence In Agriculture award winners. They farm with Greg's parents, operating a dairy and raising grain crops, alfalfa and cover crops. In addition, they raise a flock of 150 black-faced club lamb and commercial ewes. She is a 4-H advisor and past supervisor of the Soil and Water Conservation District. She is a graduate of Ohio State University with a degree in ag education.

**Steve Berk, Southwest Regional Trustee**

Steve Berk of Brookville was elected southwest regional trustee for the Ohio Farm Bureau Federation in December 2022. He represents the interests of members in 20 southwest Ohio counties. Berk, and his wife, Cynthia, manage a herd of registered Angus and SimAngus cattle focusing on show heifers and club steers. They loan their cattle to 4-H and FFA students who may not otherwise have the opportunity to gain experience in the beef industry and encourage them to engage in agriculture and Farm Bureau. He also consults for Dull Homestead Farm in Brookville and other neighboring farms on USDA programs. Berk is a member of Montgomery County Farm Bureau. He is a graduate of Ohio State University with a degree in agriculture. He spent 33 years with USDA Farm Service Agency and Foreign Agriculture Service, including four tours in Afghanistan serving as a senior agricultural advisor.

**Adam Sharp, Executive Vice President**

Adam Sharp has served as executive vice president since 2016. In his role, he serves as the chief executive of the statewide organization and leads efforts to advance its mission: Working together for Ohio farmers to advance agriculture and strengthen our communities. Sharp has more than 30 years of experience developing and implementing farm policy at the state and national levels. Prior to joining the Ohio Farm Bureau staff, Sharp held various management and government relations roles with the U.S. Environmental Protection Agency, as a White House political appointee, and with the American Farm Bureau Federation in Washington, D.C. He also served as a teaching assistant for the College of Food, Agricultural, and Environmental Sciences at The Ohio State University and as a radio producer for Agri-Broadcasting Network (ABN). He serves on various public and private boards of directors and advisory groups with the state and federal government, the food and agriculture industry and academia. A graduate of Ohio State University, Sharp was raised on a family farm in southern Ohio, which he now owns and operates with his family.



# Ohio Farm Bureau Foundation

Founded in 1983, the Ohio Farm Bureau Foundation inspires and educates the next generation of farmers, ensuring the progress and prosperity of Ohio agriculture far into the future. The foundation creates pathways for young people to learn about the variety and viability of careers in agriculture. Through scholarships, innovative programming, and grants, the foundation builds a growing workforce of farmers who are passionate and prepared to grow Ohio agricultural communities.

**Scholarships:** The foundation annually awards scholarships to students pursuing degrees, certification, and training within agriculture and its related fields.

**Innovative programs:** Ohio Farm Bureau's comprehensive agricultural literacy and ExploreAg programs are fully funded through the foundation's generous support.

**Ag Literacy:** A renewed focus on statewide ag literacy efforts was made possible by the establishment of the Patterson Family Ag Literacy Fund in 2023 which provides programmatic support in perpetuity for the Ohio Farm Bureau's agricultural literacy initiatives. Concerted efforts are being made to equip county volunteers with the skills and resources necessary to effectively conduct ag literacy experiences for youth in their local communities. Resources will also be compiled to aid with on-farm tour programs and to empower educators statewide.

**ExploreAg** is Ohio Farm Bureau's signature ag literacy and workforce development program, offering immersion programs for high-school students to learn about the variety and viability of careers within agriculture. Annually, ExploreAg engages with youth from across the state through multiple weeklong, three-day, and one-day camp experiences, all at no cost to the student.

**Grants:** The foundation awards the Growing Tomorrow Grant to help inspire, encourage, and nurture young agricultural professionals and entrepreneurs to find creative and transformative ways to address challenges facing the agricultural sector today, and to generate wider and deeper public understanding of farming and the ways that agriculture impacts our nation and our communities.

The Ohio Farm Bureau Foundation is governed by a 16-member board of directors. The board is composed of Ohio Farm Bureau members, federation trustees, organizational leaders, and many industry professionals.
